Alaska – Guardian dies of injuries incurred during rescue

The US Coast Guard issued a news release stating that a crew member of the USCGC Waesche was fatally injured during the rescue of the crew of a disabled fishing vessel near Amak Island, Alaska. (12/18/13). Note: Coast Guardsmen know the danger, but go out regardless for those in peril on the sea.

DOJ – former BP engineer convicted of obstruction of justice

The Department of Justice (DOJ) issued a news release stating that a former BP engineer was convicted in a jury trial of obstruction of justice for intentionally destroying evidence requested by federal criminal authorities investigating the April 20, 2010 Deepwater Horizon disaster. He faces a maximum penalty of 20 years in prison when sentenced on 20 March 2014.

(12/18/13). Note: This item was first brought to my attention by my good friend Ron Signorino of BlueOceana.

Corpus Christi – barge collision

The US Coast Guard issued a news release stating that two barges, one loaded with 4.2 million gallons of gas oil, collided in the Corpus Christi Ship Channel on 17 December. The other barge was empty. The towboats pushing them were headed in opposite directions, with the loaded barge outbound and the empty barge inbound. There were no reports of personal injury or pollution. The incident is under investigation. (12/17/13).

North Carolina – salvage of grounded ferry

The US Coast Guard issued a news release stating that, after an unsuccessful attempt to refloat the grounded ferry at high tide, the owner is working to submit a salvage plan to the Coast Guard. Fourteen passengers and one crewman were injured during the grounding. The incident is under investigation. (12/18/13).

Court - USCG NVIC entitled to deference

In an unpublished decision, the US Court of Appeals for the Second Circuit affirmed the district court ruling upholding the Coast Guard denial of plaintiff's application for a merchant mariner credential (MMC) as a master. The denial was based on the determination that plaintiff's cardiovascular disease posed a risk to maritime and public safety. In its decision, the appellate court stated that the Coast Guard's guidance, in the form of a Navigation and Vessel Inspection Circular (NVIC), was entitled to judicial deference. The court further stated that plaintiff did not have a property right in an MMC. Clifford v. US Coast Guard, No. 13-888-cv (2nd Cir., December 18, 2013).

Washington – emergency rule for spill contingency planning

The Washington Department of Ecology issued a news release stating that it filed an emergency rule that amends the Washington State Oil Spill Contingency Plan regulations. The amendment is intended to coordinate state requirements with new federal requirements for nontank vessel oil spill contingency plans. Additionally, the amendment clarifies that both non-profit and for-profit corporations may develop oil spill plans that cover multiple vessels.

The emergency rule will be in place for 120 days. A permanent rule will be filed soon. (12/16/13).

EC – some EU flag states struggling

The European Commission (EC) issued a press release stating that some EU Member States are struggling to meet their commitment to ratify international maritime conventions and that two Member States remain on the Paris MOU grey list. (12/18/13).

UK – port freight statistics

The UK Department for Transport (DfT) issued a **notice** providing port freight statistics for the third quarter (July-September) 2013. Compared to the same period in 2012, total major port freight tonnage dropped 1%, while total unitized traffic increased by 2%. (12/18/13).
