White House – national emergency re Somalia

The White House issued a Notice stating that President Obama has continued the national emergency with respect to Somalia, which has been determined to continue to pose an unusual and extraordinary threat to the national security and foreign policy of the United States. (4/7/14).

TSA - TWIC card services

The Transportation Security Administration (TSA) issued a notice stating that it is upgrading the technology used for issuance of Transportation

Worker Identification Credentials (TWICs). During the system upgrade, specific TWIC card services will be temporarily unavailable. Services for Card Transfers, Card Replacements, and Extended Expiration Date (EED) TWIC will be unavailable from 22 April through 4 May. If you need to utilize these services and require your TWIC prior to or during this time, place your order no later than 14 April. Card Pick-Up, Activation, and Personal Identification Number (PIN) Resets will be unavailable from 26 April through 4 May. (4/4/14).

USCG – tonnage regulations

The US Coast Guard proposes to amend its tonnage regulations by implementing amendments to the tonnage measurement law made in 2010. The proposal would also codify principal technical interpretations issued by the Coast Guard and incorporate administrative, non-substantive clarifications of and updates to the tonnage regulations. Comments on the proposal must be submitted by 7 July. 79 Fed. Reg. 19419 (April 8, 2014).

Texas City - safety zone removal

The US Coast Guard promulgated a direct final rule removing the safety zone at Snake Island (also known as Shoal Point) within the Texas City Channel. The rule will come into effect on 7 July unless adverse written comment is received by 8 May. 79 Fed. Reg. 19289 (April 8, 2014).

USCG - PWSRCAC

The US Coast Guard issued a notice stating that it has recertified, through 28 February 2015, the Prince William Sound Regional Citizens' Advisory Committee (PWSRCAC) as an alternative voluntary advisory group for Prince William Sound, Alaska. 79 Fed. Reg. 19347 (April 8, 2014).

DOS - visa and passport requirements

The Department of State (DOS) issued a final rule amending its regulations regarding the waiver by joint action of consular and immigration officers of visa and passport requirements for members of foreign armed forces and coast guards. The rule comes into effect immediately. 79 Fed. Reg. 19288 (April 8, 2014).

Mobile – grounding

The US Coast Guard issued a news release stating that it restricted traffic through the Mobile Ship Channel after the container ship MSC Kyoto grounded between buoys 36 and 38. The grounding was reportedly the result of a steering failure. There have been no reports of injury or pollution. The incident is under investigation. A second news release states that the ship has been refloated and the channel is now open. (4/7/14).

USCG - Staten Island Ferries

The US Coast Guard issued a news release stating that it regularly inspects the Staten Island Ferries, operated by the City of New York, and found that the vessels exceeded expectations in reporting marine casualties and fully cooperated with Coast Guard investigations. (4/7/14).

DOJ – guilty plea in MSC bribery case

The Department of Justice (DOJ) issued a news release stating that the former vice president of a government contracting company pleaded guilty in federal court to conspiracy to bribe federal officials in exchange for favorable treatment for several telecommunications projects with the Military Sealift Command (MSC). The individual faces a maximum penalty of five years when he is sentenced. He agreed to forfeit \$57,000 as the proceeds of the offense. Previously, four individuals, including one former government employee, pleaded guilty in connection with the conspiracy. (4/4/14).

IMO – NOx emission requirements

The Danish Maritime Authority issued a news release stating that the IMO's Marine Environment Protection Committee (MEPC) reached agreement on the entry into force date for new requirements for NOx emissions in emission control areas (NECAs). The current entry into force date of 2016 will be retained for the two existing NECAs (North America and the US Caribbean Sea). The entry into force date for new NECAs will depend on when they are decided upon. (4/4/14).

China – US SECDOD tours aircraft carrier

The Department of Defense (DOD) issued a news release stating that Defense Secretary Chuck Hagel, during his official visit to China, became the first foreign visitor to tour the Chinese aircraft carrier Liaoning. The vessel is a refitted Russian carrier. (4/7/14).

Panama Canal – March operations

The Panama Canal Authority issued an advisory summarizing Canal operations during March. It also includes the schedule of locks maintenance outages for the remainder of the fiscal year. Advisory 07-2014 (4/4/14).
