## Chicago Sanitary & Ship Canal – safety zone



The US Coast Guard issued a notice stating that it will enforce the safety zone on the Chicago Sanitary and Ship Canal from Mile Marker 296.1 to Mile Marker 296.7 at specified times from 9 June to 1 August while the US Army Corps of Engineers installs a new permanent fish barrier. Enforcement will be from 7 a.m. to 4 p.m. on 9-13 June; 16-20 June; 23-27 June; and from 7 a.m. to noon and from 1 p.m. to 4 p.m. on 30 June – 4 July; 7-11 July; 14-18 July; 21-25 July; and 28 July – 1 August. ## DOI – DWH ERP/PEIS withdrawal



The Department of the Interior (DOI) issued a notice withdrawing its earlier notice that announced the availability of a Final Programmatic and Phase III Early Restoration Plan and Final Early Restoration Programmatic Environmental Impact Statement regarding the Deepwater Horizon oil spill. When finalized, the Final Phase III ERP/PEIS will be made available to the public. [79 Fed. Reg. 34342](#) (June 16, 2014).
