
## **BOEM – offshore renewable energy**

### **House – bill introduced to prohibit Arctic Ocean drilling**



Representative Huffman (D-CA) introduced a bill (H.R. 3632) to prohibit drilling in the Arctic Ocean. ### **New Zealand – Kermadec Ocean Sanctuary**



The New Zealand Ministry for the Environment issued a **notice** [located at <http://mfe.govt.nz/marine/kermadec-ocean-sanctuary>] announcing creation of the Kermadec Ocean Sanctuary. The 620,000 square kilometer area, about 1,000 kilometers northeast of New Zealand, will be protected with restrictions addressing commercial fishing and aquaculture; recreational fishing; fishing-related tourism; and oil, gas, and mineral prospecting, exploration, and mining. ### **Singapore – port dues concession for OSVs**



The Singapore Maritime and Port Authority (MPA) issued a circular stating that the port dues concession for offshore support vessels (OSVs) has been extended from 90 days in length to 180 days, with effect from 1 November 2015 to 31 October 2016. **Port Marine Circular 11-2015** [located at [http://www.mpa.gov.sg/sites/circulars\\_and\\_notices/pdfs/port\\_marine\\_circulars/pc15-11.pdf](http://www.mpa.gov.sg/sites/circulars_and_notices/pdfs/port_marine_circulars/pc15-11.pdf)] (9/29/15).
