The Merchant Marine Personnel Advisory Committee (MERPAC), sponsored by the US Coast Guard, will meet on 13-14 September in St. Louis. Topics on the agenda include: using military education, training, and assessment

MEDMAC – meeting on 15-16 September

The Merchant Mariner Medical Advisory Committee (MEDMAC), sponsored by the US Coast Guard, will meet on 15-16 September in St. Louis. Topics on the agenda include: chiropractors; mariners prescribed medical marijuana; and over-the-counter medications. 81 Fed. Baltimore – passenger vessel allides with pier

The US Coast Guard issued a news release stating that the passenger vessel Spirit of Baltimore allided with the pier at Henderson Wharf Marina in Baltimore. There were 447 persons on board. Reports indicate cosmetic damage to the vessel and damage to 60 feet of the pier. There were no reports of pollution. The incident is under investigation. USCG – towing industry annual safety report

The US Coast Guard, in cooperation with the American Waterways Operators (AWO), released the National Quality Steering Committee's Annual Safety Report for 2015. CBP – TSCA substance importation

The US Customs and Border Protection and the Treasury Department, in cooperation with the Environmental Protection Agency (EPA) propose to amend the regulations regarding the requirement to file a Toxic Substances Control Act (TSCA) certification when importing into the customs territory of the United States chemicals in bulk form or as part of mixtures and articles containing a chemical or mixture. Comments must be received by 28 September.

BSEE – offshore production safety technologies

The Bureau of Safety and Environmental Enforcement (BSEE) issued a press release stating that the final rule regarding safety and maintenance requirements for offshore oil and gas production technologies has been approved and forwarded to the Office of the Federal Register for publication. Court - TLP is not a vessel

The US Court of Appeals for the Fifth Circuit affirmed the denial of benefits under the Longshore and Harbor Workers' Compensation Act (LHWCA) to an employee allegedly injured in the employer's waterside marine fabrication yard while building a housing module designed for use on a tension leg offshore oil platform (TLP). The court held that the TLP is not a vessel and that plaintiff's activities did not have a sufficiently substantial nexus to outer continental shelf (OCS) operations. Baker v. Gulf Island Marine Fabricators, No. 15-60634 (5th Cir., August 19, 2016) [http://www.ca5.uscourts.gov/opinions/pub/15/15-60634-CVo.pdf]. Micronesia – AMVER vessel spots survivors

The US Coast Guard issued a news release stating that two individuals were rescued from an uninhabited island in the Federated States of Micronesia (FMC) following a seven-day search effort by multiple assets including 14 AMVER vessels. During the search, one of the AMVER vessels spotted flashing lights from the island. The Coast Guard vectored a USN search plane to the island and the individuals were sighted. A FSM patrol boat then completed the rescue. (8/26/16)

UK –post implementation review of regulations

The UK Maritime and Coastguard Agency (MCA) is opening a statutory Post Implementation Review (PIR) of its Merchant Shipping (Safety of

Navigation) (Amendment) Regulations 2011 to assess whether those amendments are still fit for purpose. The regulations were implemented in order to ensure that the master's discretion in decision-making is not compromised and to stipulate carriage requirements and necessary performance standards for Long Range Identification and Tracking (LRIT) equipment. Comments must be received by 16 September. (8/26/16)
