Florence Ebersole Smith Finch (1915-2016)



The US Coast Guard issued a **news release** announcing funeral services with full military honors on 29 April in Ithaca, New York for Florence Ebersole Smith Finch (1915-2016). She was born in the Philippines to an American father and a Filipino mother, making her a dual-citizen. At the outbreak of World War II, she worked as a civilian stenographer with the Office of Army Intelligence. After American forces withdrew, she remained in country, didn't acknowledge her American connections, and was hired by the Japanese-controlled Philippine Liquid Fuel Distributing Union. In this position, she helped American prisoners of war and wrote various vouchers to assist the Philippine resistance movement. She was eventually arrested and tortured. For nearly five months she was held in a two-by-four-foot cell and deprived of most subsistence. Freed by American forces in February 1945, she moved to the United States, where she joined the US Coast Guard Women's Reserve (SPARS). Ms. Finch was the first woman to receive the Asiatic-Pacific Campaign Ribbon. She was also awarded the Medal of Freedom, the highest civilian award of the US Government. White House – offshore energy strategy



President Trump issued an **Executive Order** stating that it is the policy of the United States to encourage energy exploration and production, including on the outer continental shelf. The Secretary of the Interior is directed to give full consideration to revising the schedule of proposed oil and gas lease sales that it includes, but is not limited to, annual lease sales to the maximum extent permitted by law and to develop a streamlined permitting approach for privately funded seismic data research and collection. Galveston – disabled tug and barge stabilized



The US Coast Guard issued a **news release** stating that a disabled tug and its integrated barge have been stabilized in heavy weather off Galveston. USCG – approval of navigational equipment for ships



The US Coast Guard issued Change 3 to its Navigation and Vessel Inspection Circular (NVIC) entitled ‘Approval of Navigation Equipment for Ships. USCG – MTS planning



The US Coast Guard issued an internal instruction entitled “Marine Planning to Operate and Maintain the Marine Transportation System (MTS) and Implement National Policy”. The Instruction promulgates Coast Guard policy, roles, and responsibilities in marine planning to carry out statutory requirements, as well as implementation of Executive Orders, such as the National Ocean Policy, and subsequent guidance that may require extraordinary consideration in conjunction with ongoing planning and operations.

MARAD – USMMA Sea Year



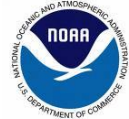

House – bill introduced to ban OCS drilling



Representative Huffman (D-CA) introduced a bill (H.R. 2242) to prohibit drilling in the outer Continental Shelf, to prohibit coal leases on Federal land, and for other purposes. Official text of the bill is not yet available. (4/28/17).

House – bill introduced re OCS leasing moratorium



Representative Sanford (R-SC) introduced a bill (H.R. 2252) to amend the Outer Continental Shelf Lands Act to place a ten-year moratorium on oil and gas preleasing, leasing, and related activities on the Outer Continental Shelf in the North Atlantic, Mid-Atlantic, South Atlantic, and Straits of Florida planning areas and in the Eastern Gulf of Mexico. Official text of the bill is not yet available, but Representative Sanford issued a **press release** explaining the measure. House – bill introduced re OCS leasing



Representative Brat (R-VA) introduced the **Outer Continental Shelf Energy Access Now (OCEAN) Act** (H.R. 2157) to amend the Outer Continental Shelf Lands Act to limit the authority of the President to withdraw areas from oil and gas leasing, and for other purposes. House – bill introduced to ban Atlantic seismic airgun activities



Representative Beyer (D-VA) introduced the **Atlantic Seismic Airgun Protection Act** (H.R. 2158) to amend the Outer Continental Shelf Lands Act to prohibit oil-, gas-, and methane hydrate-related seismic activities in the North Atlantic, Mid-Atlantic, South Atlantic, and Straits of Florida planning areas of the outer Continental Shelf, and for other purposes. House – bill introduced re passenger vessel safety



Representative Matsui (D-CA) introduced the **Cruise Passenger Protection Act** (H.R. 2173) to improve passenger vessel security and safety, and for other purposes. Senate – bill introduced re OCS leasing



Senator Cassidy (R-LA) introduced a bill (S. 956) to amend the Outer Continental Shelf Lands Act to limit the authority of the President to withdraw areas from oil and gas leasing, and for other purposes. Official text of the bill is not yet available, but Senator Cassidy issued a **press release** explaining the measure. Senate – bill introduced re coral reef ecosystems



Senator Hirono (D-HI) introduced a bill (S. 958) to authorize Federal agencies to establish prize competitions for innovation or adaptation management development relating to coral reef ecosystems, and for other purposes.
