## USCG – performing inspections also performed by ROs

The US Coast Guard issued guidance to USCG marine inspectors performing inspections on US-flag vessels where certain delegated functions are also performed by Recognized Organizations (ROs). This guidance formalizes a

process, known as a Quality Case, for the Coast Guard to request an internal investigation or root cause analysis when objective evidence indicates that a potential failure or lack of effectiveness of the Recognized Organization's Quality Management System resulted in the unsatisfactory execution of delegated function(s).
